Meeting Called to Order at 9:34AM with the Pledge of Allegiance lead by R. Seitz

OPENING REMARKS/OFFICER REPORTS:

Assistant Director: R. Hall had nothing specific to report at this time however, thanked all chapter members for participating on his local chapter ride held June 10 to the Irish Cottage Inn.

Treasurer: R. Seitz thanked all for a great overnight trip to Niagara Falls. R. Seitz confirmed the chapter's finances to be in good standing and that monies will be subtracted to pay for the chapter T-shirts that were just ordered. MA Breuninger asked if the chapter would consider donating to both CTC & A. Sandoval given the upcoming Saturday charity ride and appearance event? R. Breuninger confirmed yes.

Secretary: DA Ryan shared that over 60-chapter t-shirts were ordered by members and that the order was placed with Norscot on June 5 with expected delivery to be anywhere from three-(3) to four-(4) weeks and that members will be notified once the shirts are received.
